Comment: The location has not established a uniform perennial vegetation cover of at least 80% of reference area levels. There are areas with no vegetation cover that are susceptible to erosion. There are also areas where vegetation is progressing. Additional reseeding of bare soil areas needs to be performed before the upcoming growing season. Continue to monitor and maintain the location until the final reclamation requirements are achieved.

Comment: There are erosion issues observed along the access road and location. The rock check dams have filled in with sediment causing erosion of the road. The stormwater diversion at the southwest side of location has eroded and will need further stabilization. BMP's will need to be maintained until final reclamation is achieved.
