Immediately cease all gas sales pursuant to Order 1V-863. Further gas sales from this battery is a violation of Rule 219 and Order 1V-863</p> <p>All balon valves appear to be open on separator and gas meter line. Pressure appears on separator and gas meter lines by psig.
