<p>COGCC Inspection Report Summary</p> <p>On Friday 2/24/2023 at approximately 10:10 hours, I, Inspector Tom Peterson, conducted an on-site inspection at the KPK Kammerzell 1-9 battery API #123-11436 in Weld County, Colorado.</p> <p>While there, I observed that the DCP gas sales meter station #23149 appeared to have current product sold. The following possible compliance issues were observed: Immediately cease all gas sales pursuant to Order 1V-863. Further gas sales from this battery is a violation of Rule 219 and Order 1V-863 with a corrective action date of 2/24/2023.
