Pursuant to COGCC Rule 911 a site investigation was conducted pertaining to the JOHNSON 20-29 wellhead cut and cap and flowline removal. Approximately 1367' of flowline was removed. The wellhead was cut and capped per COGCC rules.

Two (2) grab confirmation soil samples were collected at the wellhead excavation (1) and flowline terminus (1). Soil samples were analyzed by a certified laboratory for TPH (total volatile [C6-C10] and extractable [C10-C36] hydrocarbons), organic compounds in soil per COGCC Table 915-1, EC, SAR, pH, and boron. All samples collected were analyzed by a certified laboratory using approved COGCC laboratory analysis methods.
