<p>Following facility decommissioning operations at the Thompson 33&43-6 O SA location on March 3, 2023, four confirmation soil samples were collected from two former separators. Soil samples SEP-B01@3" through SEP-B04@3" were submitted for laboratory analysis of benzene, toluene, ethylbenzene, and total xylenes (BTEX), naphthalene, 1,2,4-trimethylbenzene (TMB), 1,3,5-TMB, total petroleum hydrocarbons (TPH) - gasoline range organics (GRO: C6-C10) by United States Environmental Protection Agency (USEPA) Method 8260D, TPH - diesel range organics (DRO: C10-28) and oil range organics (ORO: C28-C40) by USEPA Method 8015D, pH, specific conductance (EC), sodium adsorption ratio (SAR) by saturated paste method, and boron by hot water soluble soil extract method. Preliminary analytical results received on March 6, 2023, indicate that the naphthalene, 1,2,4-TMB, and 1,3,5-TMB concentrations in soil sample SEP-B03@3" exceeded the COGCC Table 915-1 Cleanup Concentrations. Excavation and assessment activities are ongoing and will be summarized in a forthcoming quarterly Form 27- Supplemental Site Investigation and Remediation Workplan under Remediation Project No. 24730 (approved Form 27 Document No.403129478). A topographic Site Location Map showing the geographic setting of the release is provided as Figure 1. Field notes and a photographic log are provided as Attachment B. The State Notification email is provided as Attachment C.</p>
