INITIAL ACTION SUMMARY

Description of initial action or emergency response measures take to abate, investigate, and/or remediate impacts associated with E&P Waste.

Pursuant to COGCC Rule 911 a site investigation will be conducted pertaining to the HOFFMAN 3-24 wellhead cut and cap and flowline removal. Approximately 1946' of flowline will be removed, however a portion of the flowline will be abandoned-in-place due to field constraints. The COGCC will be updated in a supplemental Form 27. The wellhead will be cut and capped per COGCC rules. Additionally, soil samples will be collected at any points of material change and/or hammer unions, directional changes, as well as at the bell holes on either side of a waterway, AS APPLICABLE to abandonment type. The Flowline Pre-Abandonment Notice Document number is included under Related Forms.

A grab soil sample will be collected at the base of the excavation or the area showing the highest degree of impact during field screening activities at the wellhead excavation. Additionally, soil samples will be collected at any points of material change and/or hammer unions, directional changes, as well as at the bell holes on either side of a waterway, AS APPLICABLE to abandonment type. A grab confirmation soil sample will be collected at the wellhead excavation. Soil samples will be analyzed by a certified laboratory for TPH (total volatile [C6-C10] and extractable [C10-C36] hydrocarbons) organic compounds in soil per COGCC Table 915-1, and EC, SAR, pH, and boron. All samples collected will be analyzed by a certified laboratory using approved COGCC laboratory analysis methods.

	Upon cap and cut of the wellhead, Operator will field screen a minimum of four sidewall samples and collect a minimum of one base sample in the excavation for lab analysis.
	Operator shall conduct an environmental investigation and submit for laboratory analysis to confirm the presence or absence of impacts adjacent to the flowline in the following locations: -where the line crosses the unnamed water. These samples can be obtained by a hand auger boring.
	Operator shall conduct an environmental investigation and field screen to confirm the presence or absence of impacts adjacent to the flowline at a minimum of every 250'.
	Location lies within the recommended buffer of a Burrowing Owl Active Nest Site. Please note that Approval of this Form 27 does not supersede any Federal, State or Local regulations pertaining to the Migratory Bird Treaty Act. COGCC recommends consultation with Colorado Parks and Wildlife.
