

Set CIBP @ 4800', 2 sacks cement.
Perfs @ 4933' - 4939'.
40 sacks 1/2 in, 1/2 out @ 206'. - CUT - PULLED FROM 2,400'
10 sacks @ surface.
Cut and weld steel plate 4' below ground level.

All cement was 50/50 poz, yield is 1.26 cu. ft./sack, weight is 15.1 ppg.
