Operator Comment: The topsoil pile from the original 5" of material stripped was track packed previously, is now frozen, and serves as a BMP protecting the north side of the second topsoil pile. The topsoil piles contain significant clay and are frozen and thus are not subject to wind erosion at this time of year.

2/4/2023 Response

St. Croix restates that interim or final reclamation will occur as soon as weather conditions allow and also restates that frozen soil conditions provide adequate soil compaction to ensure site conditions and controls are adequate and in place to effectively manage stormwater per Rule 1002.f (2) (D).
