INITIAL ACTION SUMMARY

Description of initial action or emergency response measures take to abate, investigate, and/or remediate impacts associated with E&P Waste.

This form has been prepared to support removal of a wellhead and on-location flowline. The flowline was removed. In accordance with COGCC Rule 911 and Rule 915, initial representative soil samples will be collected beneath the wellhead. Initial laboratory soil analysis will include only BTEX, 1,2,4 and 1,3,5 Trimethylbenzene, naphthalene, TPH, pH, EC, SAR and boron. Soil samples collected beneath the off-location flowline will be field screened, and a lab analysis submitted if impacts are identified. Groundwater, if present, will also be collected and analyzed.

Crestone will sample for the COGCC approved Table 915-1 soil analysis plan to include TPH C6-36, organics, arsenic, barium, cadmium, lead, nickel, selenium, pH, EC, SAR, and boron. Following lateral and vertical definition of impacts, source removal through excavation will be scheduled.
