INITIAL ACTION SUMMARY

Description of initial action or emergency response measures take to abate, investigate, and/or remediate impacts associated with E&P Waste.

Wellhead cut and cap operations were completed at the Upson 14-6 wellhead on October 26, 2022. Groundwater was not encountered in the wellhead cut and cap excavation area. Visual inspection and field screening of soils around the well and associated pumping equipment was conducted following wellhead cut and cap operations, and a soil sample (WH-B01@6') was submitted for laboratory analysis to determine if a release occurred. The flowline associated with this wellhead was removed on October 26 and 27, 2022, and soil samples were collected from the locations where the flowline risers were disconnected at the wellhead (FL-B01@4') and separator (FL-B08@4'), and where the flowline changed direction (FL-B07@4') and submitted for laboratory analysis to determine if a release occurred. A topographic Site Location Map showing the geographic setting of the site location is provided as Figure 1. Soil sample location and field screening data are presented in Table 1. Soil analytical results are summarized in Tables 2 and 3. The wellhead soil sample and field screening locations are illustrated on Figure 2. The flowline soil sample and field screening locations are illustrated on Figure 3.

On October 26 and 27, 2022, soil samples were collected from the base of the cut and cap excavation area (WH-B01@6'), from two locations where the flowline risers were disconnected at the wellhead (FL-B01@4') and separator (FL-B08@4'), and where the flowline changed direction (FL-B07@4'). The soil samples were submitted for laboratory analysis of BTEX, 1,2,4- and 1,3,5-TMB, naphthalene, TPH-GRO (C6-C10), DRO (C10-C28), and ORO (C28-C40), pH, EC, SAR, and boron using standard COGCC-approved methods. Analytical results indicated that constituent concentrations in the confirmation soil samples collected during wellhead cut and cap and flowline removal activities were in compliance with COGCC Table 915-1 standards and/or within the range of site-specific background levels. Soil analytical results are summarized in Tables 2 and 3.

Additional Investigative Actions

On October 26 and 27, 2022, visual inspection and field screening of soils was conducted at 4 sidewall locations within the cut and cap excavation area, 4 locations at the ground surface adjacent to the excavation, and 5 pothole locations during flowline removal. Based on the inspection and screening results, hydrocarbon-impacted soil was not observed at the screening locations, and no soil samples were submitted for laboratory analysis from these areas in accordance with COGCC Operator Guidance. On October 27, 2022, a soil gas survey was conducted at 5 soil vapor points (SVP01 - SVP05) installed adjacent to the former wellhead location following cut and cap operations. GEM 5000 field readings were non-detect for methane at all 5 soil vapor points. The SVP locations are illustrated on Figure 2 and SVP screening results are summarized in Table 4. The laboratory analytical reports are provided as Attachment A. The field notes and a photographic log are provided as Attachment B.

Background soil samples BG-01 @3' - BG-02 @3', and BG-01 @6' - BG-02 @6' were collected from native material adjacent to the wellhead cut and cap excavation. The background soil samples were submitted for laboratory analysis of the Soil Suitability for Reclamation Parameters using standard methods appropriate for detecting the target analytes in Table 915-1. Analytical results for the background soil samples are presented in Table 3.

Laboratory results indicate that constituent concentrations in the soil samples collected from the base of the wellhead cut and cap excavation area (WH-B01@6'), and during flowline removal (FL-B01@4', FL-B07@4' and FL-B08@4'), were in compliance with COGCC Table 915-1 standards and/or within the range of site-specific background levels; therefore no soils were removed during wellhead cut and cap or flowline removal operations. The excavation areas were backfilled and contoured to match pre-existing site conditions.

REMEDICATION SUMMARY

Laboratory results indicate that constituent concentrations in the soil samples collected from the base of the wellhead cut and cap excavation area (WH-B01@6'), and during flowline removal (FL-B01@4', FL-B07@4', and FL-B08@4'), were in compliance with COGCC Table 915-1 standards and/or within the range of site-specific background levels. Groundwater was not encountered in the cut and cap excavation area or flowline removal potholes. Based on the analytical and soil screening data presented herein, assessment is complete at this site and no further activities are required. As such, Kerr-McGee is requesting a No Further Action (NFA) determination for this location.
