Comment:	<p>Previous inspection #702801227 observed staining at separator. Inspector required Operator to conduct maintenance on equipment, cleanup stained material and review self inspection processes by 2/11/23. Operator submitted FIRR #403326727 indicating stains have been removed.</p> <p>It was observed in this inspection that staining remains beneath the separator. Additionally, snowmelt revealed additional staining at the back of the separator. Staining is approximately 4 feet in length and an unknown width (due to snow cover). Operator shall provide specific details on the cause/nature of the staining in an FIRR. Original observed stain on gravel at the front of the separator remains; corrective action and date remain applicable.</p>
