Comment Areas of the location not needed for production, or no longer in use have been reduced and reclaimed. No noxious weed concerns observed at the time of this inspection. Introduced and native perennial grasses (crested wheatgrass, Russian wildrye, Sporobolus sp.) and native shrubs (rubber rabbitbrush) appear established. However, dormant season prevented a full vegetation assessment. A follow up inspection will be conducted during a future growing season to determine compliance with 1003 requirements.

**Comment:** Previous inspection #700704510 observed access road not maintained (weeds/erosion). Inspector required Operator to maintain access road. Operator submitted FIR Resolution #403201296 indicating road was repaired.

It was observed in this inspection that gravel has been added to the access road. The addition of gravel to the access road does not appear to have addressed rill and gully erosion occurring to the south of the access road in multiple areas. Soils are bare and unprotected and are subject to wind and water erosion. No perennial vegetation or other BMPs observed to stabilize and protect soils and to mitigate the movement of sediment offsite.

**Corrective Action:** Install or repair required BMPs per Rule 1002.f. Continue to monitor and manage stormwater on the Location. Ongoing stormwater management is required until the site receives a passing final inspection.
