**General Comment:**

COGCC Inspection Report Summary

On Wednesday 3/15/2023, I, Inspector Scott Ramsey, conducted a follow up inspection at TEP Miller 10, at Location # 423439 in Garfield county Colorado.

Any Corrective Actions from previous Inspections that have not been addressed are still applicable.

While there, I observed normal production operations. This location is within or in close proximity to a CPW Density/High Priority Habitat, black bear, NSO habitat, Wildlife Management. Operator (TERRA) has provided there Piceance Basin Storm water Manual of BMP's (SC-4) for a tracking pad.

C/A (Lack of stabilization/compaction/tracking BMP's) has not been addressed from previous inspection document # 700703642.

During this inspection the following compliance issues were observed:

1. Meter calibration card not conspicuously posted.
2. Lack of stabilization/compaction/tracking BMP's
3. Random debris
