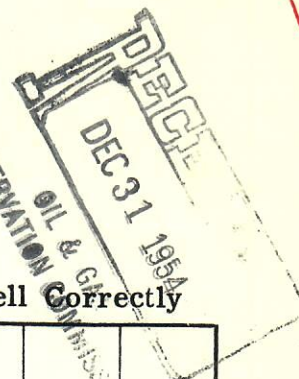

Ran Schlumberger DST #1--5071-82', tool open 75 minutes, SI 15 min, rec. 2790' clean oil. FP950 #SIP 1200#. DST#2-(upper bench "J" sand) 5014-34, tool open 1 1/2 hrs., SI 15 min., rec. 2350 heavy gas-cut water. FP 925# SIP 950#. Ran 5 1/2" casing, landed at 5126' RB. Perforated 5 1/2" casing 5070-81'.

Initial pumping potential 186 BOPD. Gravity 41. 16 strokes per minute, 54" stroke, 1 1/2" stroke. Tubing pressure 0# casing pressure 10#.
