This form has been prepared to provide prior notice of the plugging and abandonment of the Jensen (OWP) #12-1 wellhead and the removal of the associated facility. In accordance with COGCC Rule 911.a., soil and groundwater (if present) samples will be collected and submitted for laboratory analysis to determine if concentrations and values are in compliance with COGCC Table 915-1. Visual inspection and field screening of soils around the wellhead, associated flowline(s), and associated facility will be conducted during sampling activities. Soil vapor screening will also be performed around the wellhead.

Soil samples will be collected for laboratory analysis of Table 915-1 constituents from areas most likely to have been impacted. Visual inspection and field screening of soils will be conducted in the areas surrounding the flowline(s) if present, around the wellhead, below tank(s), below separator(s), and around any other production equipment, if present. Based on field screening and observations, discrete soil samples will be collected and submitted for laboratory analysis of Table 915-1 constituents. Proposed soil sample and screening locations are provided on Figure 1 attached.
