There will be two additional SAR samples collected as part of the investigation in response to the exceedances presented in Soil sampling round 1, conducted on 10/27/2022. To meet form 19 initial requests, organic compounds in soils, TPH, and metals in soils were conducted. However, due to field and lab confusion, SAR was not sampled for on SS1 and SS3 locations. These are being conducted at the beginning of this quarter.

The Source for Removal, ENR's agricultural grade produced water, will be removed from the Chateau Pit through natural attenuation. With rainfall, and primarily snowmelt, ENR will continue to monitor the soil sample levels within the pit, quarterly.

Pit source impacts and the need for remediation are continuing to be evaluated.
