Comment: Desert Eagle Operating has addressed the soil disturbance by grading at the wellsite and continues to address soils disturbed along the flowline by grading soil to be utilized for reclamation; removing trees and depositing them at a landowner approved location; and removing rocks left at the surface and trucking them to a raw materials location. Disturbed, compacted soil from heavy equipment will be de-compacted for reclamation. Contractors have been instructed to minimize surface disturbance and avoid compacting the soil during the aforementioned activities. Pipe stored along the flowline has been removed. All Corrective Actions are targeted for completion prior to the 3/30/23 Correction Action date.
