1). Form 42 was submitted prior to plugging operations, Form 42 Doc # 403308268. Form 42 was submitted prior to MIRU for plugging operations, Form 42 Doc # 403308248.

2). After placing plug at 2200', operator waited a sufficient amount of time to confirm static conditions. There was no pressure or fluid migration.

3). No fluids or gas migration was present prior to cement plug to surface being set. The plug was cemented to surface with 640 sacks of cement from 442' and topped off w/ 25 sx at surface (Total sx 665)

4). At least 100' of cement was left in the wellbore for each plug.

5). This form 6-SRA addresses all COA's from the Form 6-NOIA.
