INITIAL ACTION SUMMARY

Description of initial action or emergency response measures take to abate, investigate, and/or remediate impacts associated with E&P Waste.

On October 11, 2022, the removal of two flowlines and risers associated with the former Glens #2, 6, 10 VV 6-14 O SA production facility was completed. Visual inspection and field screening of soils was conducted at the former flowline locations following their removal, and soil samples were collected from the former flowline riser locations (FL-B01@4' and FL-B04@3') and submitted for laboratory analysis to determine if a release occurred. A topographic Site Location Map showing the geographic setting of the site location is provided as Figure 1. Soil sample location and field screening data are presented in Table 1. The flowline soil sample and field screening locations are illustrated on Figure 2.

PROPOSED SAMPLING PLAN

Proposed Soil Sampling

On October 11, 2022, two (2) confirmation soil samples were collected from the former flowline riser locations (FL-B01@4' and FL-B04@3'). The soil samples were submitted for laboratory analysis of benzene, toluene, ethylbenzene, and total xylenes (BTEX), naphthalene, 1,2,4-, and 1,3,5-trimethylbenzene (TMB), and total petroleum hydrocarbons (TPH) - gasoline range organics (GRO: C6- C10) by USEPA Method 8260D, TPH - diesel range organics (DRO: C10-C28) and oil range organics (ORO: C28-C40) by USEPA Method 8015D, pH, specific conductance (EC) and sodium adsorption ratio (SAR) by saturated paste method, and boron by COGCC-accepted method. Analytical results indicated that constituent concentrations in the confirmation soil samples collected during flowline and riser removal activities were in compliance with COGCC Table 915-1 standards and/or within the range of site-specific background levels. Soil analytical results are summarized in Tables 2 and 3.

Additional Investigative Actions

On October 11, 2022, visual inspection and field screening of soils was conducted at 2 locations during flowline removal activities. Based on the inspection and screening results, hydrocarbon-impacted soil was not observed at the soil screening locations. As a result, no soil samples were submitted for laboratory analysis from these areas in accordance with the COGCC Operator Guidance for Oil & Gas Facility Closure document. Soil sample location and field screening data are presented in Table 1. Soil analytical results are summarized in Tables 2 and 3. The soil sample and field screening locations are illustrated on Figure 2. The laboratory analytical reports are provided as Attachment A. The field notes and a photographic log are provided as Attachment B.

Twelve (12) background soil samples were collected from native material adjacent to the former flowline and riser locations, and from the nearby Dacono ST 39-36 site. The background soil samples were submitted for laboratory analysis of the Soil Suitability for Reclamation Parameters using standard methods appropriate for detecting the target analytes in Table 915-1. Analytical results for the background soil samples are presented in Table 3.

Laboratory results indicate that constituent concentrations in the 2 confirmation soil samples collected from the former flowline riser locations (FL-B01@4' and FL-B04@3') were in compliance with COGCC Table 915-1 allowable levels and/or within the range of site-specific background results; therefore no soils were removed during flowline and riser removal activities. The excavation areas were backfilled and contoured to match pre-existing site conditions.

REMEDIATION SUMMARY

Describe how remediation of existing impacts to soil and groundwater is to be accomplished (i.e. summarize remedial action plan). Laboratory results indicate that constituent concentrations in the 2 confirmation soil samples collected from the former flowline riser locations (FL-B01@4' and FL-B04@3') were in compliance with COGCC Table 915-1 allowable levels and/or within the range of site-specific background results. Groundwater was not encountered during flowline and riser removal activities. Based on the analytical and soil screening data presented herein, assessment is complete at this site and no further activities are required. As such, Kerr-McGee is requesting a No Further Action (NFA) determination for this location.
