On Tuesday, 03/14/2023, Inspector Kirby Burchett, conducted a routine field inspection at Caerus Piceance LLC on Facility #446952, Location #316151, in Rio Blanco County, Colorado. This location is within or in close proximity to a Parks and Wildlife (CPW) District Wildlife Management Plan with Black Bear, High Priority, NSO, and Density Habitats.

Any Corrective Actions from previous Inspections are still applicable.

While there, observing normal operations the following compliance issues were found:

1. Random debris.
  2. Unused equipment.
  3. Open end loadlines.
  4. Chemical tank containment full.
  5. Catch can under loadline full of liquid.
  6. Production tank capacity information missing.
  7. Filter station lacking maintenance. Oily waste.
  8. No evidence of Stormwater BMPs for vehicle tracking.

A follow up on this site inspection will be conducted to ensure all compliance issues have been corrected to comply with COGCC rules.
