COMMENTS:

The Sater C23-24 (05-123-25489) is a leasehold well currently listed as Option 1/2 COA for the Booth C35-745 (05-123-48924) as well as the other 7 wells on the D02-02 Multi . Noble respectfully requests a change to Option 4. The well is 114' away from the closest lateral and located in a field that will go into crop by the end of March. Surface casing is set at 606' and production casing cement top is at 1950'. The deepest water well depth is 120'. The Foxhills is at 321'. The Niobrara top is 6507'. We will set an RBP above the perforations and upgrade the wellhead to 5K rated. Additionally, we will shut the well in and install a pressure transducer that will continuously monitor the casing and surface casing throughout hydraulic fracture stimulation operations for any pressure anomalies observed.
