 Procedure: A surface pipe plug was used with 10 sacks at the top and 30 sacks on the bottom of the surface casing. The top of the surface casing was cut off and a steel cap was welded on. Permission to plug was granted by Mr. Bicknell of the Colorado Oil and Gas Commission.
