Photo 6. Facing southwest from the northeast corner of the construction. It appears temporary BMPs (surface roughening) have been installed during the initial site construction. On-site contractor advised that straw wattles would be installed at a later date. Some BMPs are still in-process (sediment traps, etc). More permanent stormwater BMPs should be selected after pad construction is completed. Topsoil stockpiles also pictured on the interior perimeter of the disturbance area.
