## **ASSIGNMENT, BILL OF SALE AND CONVEYANCE**

This Assignment, Bill of Sale and Conveyance (this “*Assignment*”) is dated January 28, 2022, but effective as of 7:00 a.m. Mountain Time on August 1, 2021 (the “*Effective Time*”), by and between **BERRY PETROLEUM COMPANY, LLC**, a Delaware limited liability company, whose address is 16000 N. Dallas Pkwy., Suite 500, Dallas, TX 75248 (“*Assignor*”), and **CAERUS PICEANCE LLC**, a Colorado limited liability company, whose address is 1001 17<sup>th</sup> Street, Suite 1600, Denver, CO 80202 (“*Assignee*”). Assignor and Assignee are sometimes referred to herein individually as a “*Party*” and collectively as the “*Parties*. Capitalized terms used but not otherwise defined herein shall have the respective meanings given to such terms in that certain Purchase and Sale Agreement, dated as of September 15, 2021, by and between Assignor and Assignee (as the same may be amended from time to time, the “*Purchase Agreement*”).

### **ARTICLE 1** **CONVEYANCE OF ACQUIRED ASSETS**

Section 1.1 **Conveyance of Acquired Assets.** For and in consideration of the sum of Ten Dollars (\$10.00) and other good and valuable consideration, the receipt and full sufficiency of which are hereby acknowledged, Assignor does hereby GRANT, BARGAIN, SELL, CONVEY, TRANSFER, ASSIGN, SET OVER and DELIVER to Assignee, and Assignee hereby accepts from Assignor, all of Assignor’s right, title and interest, whether real or personal, recorded or unrecorded, tangible or intangible, vested, contingent or reversionary, in and to the following (but excepting and excluding the Excluded Assets (as defined below)) (collectively, the “*Acquired Assets*”):

(a) the oil and gas leases described on **Exhibit A** (collectively, the “*Leases*”), together with all other interests of any kind or character in and to the Leases (including all working interests, net revenue interests, overriding royalties, production payments, net profits interests, carried interests, reversionary interests and other Hydrocarbon interests of any kind or character derived from the Leases) and the lands covered by the Leases (the “*Lands*”);

(b) all oil, gas, water, carbon dioxide, water disposal, injection and other wells located on any of the Leases or on any other lease or lands with which any Lease has been unitized or pooled therewith, whether such wells are producing or non-producing, including but

not limited to those wells described on **Exhibit B** (the “*Wells*” and together with the Leases and Lands, the “*Acquired Properties*”);

(c) all rights and interests in, under or derived from all unitization, pooling, and communitization agreements, declarations, and orders in effect with respect to any of the Leases or Wells and the units created thereby, including but not limited to the unit agreements described on **Exhibit C** (the “*Units*”);

(d) all natural gas and water pipeline systems including, without limitation, the pipelines described on **Exhibit F** to the Purchase Agreement, which, for the sake of clarity, shall include all pipelines, gathering lines and flowlines owned by Assignor related to the Lands and the associated rights-of-way, easements, equipment and machinery including, without limitation, the meters and compressors described on said **Exhibit F** to the Purchase Agreement (the “*Midstream Assets*”);

(e) the rights-of-way, Easements, surface leases, surface use agreements and other surface rights necessary or useful for or related to the Acquired Properties, Units and Midstream Assets, including without limitation, those described on **Exhibit E** (the “*Surface Rights Agreements*”);

(f) all Hydrocarbon sales, purchase, gathering, and processing contracts, operating agreements, balancing agreements, and other contracts and agreements in connection with the operations of the Acquired Assets to which Assignor is a party and/or which bind the Acquired Assets described in this Section 1.1, including without limitation the Contracts and agreements listed on **Exhibit G** (the “*Material Contracts*”);

(g) all Permits;

(h) all (i) Hydrocarbons (and the proceeds from the sale of Hydrocarbons) attributable to the Leases and/or Wells to the extent (A) such Hydrocarbons were produced from and after the Effective Time or (B) were located as of the Effective Time in pipelines or in tanks upstream of the pipeline sales connection and (ii) Imbalances;

(i) all owned and leasehold interests in the equipment, machinery, fixtures and other personal property related to the Lands including, without limitation, the personal property described on **Exhibit I** to the Purchase Agreement (which exhibit separately identifies whether such property is owned or leased);

(j) except for Claims, payments, and proceeds under insurance policies, all rights to payment arising out of or attributable to the Acquired Properties accruing or attributable to any period from and after the Effective Time, and all rights, Claims, refunds, causes of action, or choses in action relating to the foregoing;

(k) to the extent assignable, all warranties and rights to indemnification and defenses attributable to the Acquired Assets described in subsections (a) through (j) above;

(l) electronic digital copies and originals, to the extent such originals are in the possession or control of Assignor or its Affiliates, of any files, records, information and data,

whether written or electronically stored, in each case to the extent relating to the Acquired Assets, including: (i) land and title records (including abstracts of title, title opinions and title curative documents); (ii) contract files; (iii) correspondence; (iv) operations, environmental (including all environmental compliance records, environmental safety, risk, asset integrity/mechanical integrity audits, reviews, and studies and all environmental reports, assessments, studies, or other compilations, regardless of whether such items are prepared for internal or external purposes), production, and accounting records; (v) production, facility and well records and data, (vi) records related to the testing, mapping, or other identification of any gathering line, flowline, or other pipeline, including all such records prepared in connection with any rulemaking conducted by the Colorado Oil and Gas Conservation Commission (the “**Records**); provided, however, that the term “Records” shall not include any of the Excluded Assets;

(m) the benefits derived from any Identified Tax Credits associated with the Acquired Assets applicable to any calendar year commencing after December 31, 2019;

(n) all funds held in suspense by Assignor that are owed to third parties with respect to the operation or ownership of the Acquired Properties as described in Exhibit J to the Purchase Agreement; provided, however, that “Suspense Funds” does not include any “negative suspense” or any amount owed to Assignor or any of its Affiliates (or otherwise characterized as an account receivable to Assignor or any of its Affiliates) as a result of overpayment of proceeds from production. (the “**Suspense Funds**”); and

(o) to the extent not subject to (i) payment of a transfer, licensing or similar fee, penalty or other consideration under third party agreements or (ii) obtaining any consent that is not obtained after the exercise of commercially reasonable efforts by Assignor, a non-exclusive, non-transferable license to receive copies of all Technical Data to the extent relating to the Acquired Properties.

TO HAVE AND TO HOLD the Acquired Assets, together with all rights, privileges and appurtenances thereto, unto Assignee and its successors and assigns forever, subject to the reservations, covenants, terms and conditions set forth in this Assignment.

Section 1.2 **Excluded Assets**. Notwithstanding Section 1.1, the Acquired Assets shall not include the following assets of Assignor (the “**Excluded Assets**”):

(a) all accounts receivable or rights to payment, refund, or indemnity accruing or attributable to any period before the Effective Time, including the right to any payments with respect to any royalties, the full benefit of all Liens, security for such accounts or rights to payment accruing or attributable to any period before the Effective Time or that include or relate to any of the Retained Liabilities, and all rights, Claims, refunds, causes of action, or choses in action relating to the foregoing;

(b) all production of Hydrocarbons (and proceeds from the sale of Hydrocarbons) from or attributable to the Acquired Assets with respect to any period before the Effective Time;

(c) all insurance policies, and any Claims, payments, and proceeds under any such insurance policies;

- (d) all deposits, surety bonds, letters of credit, collateral and other type of security or credit support posted prior to the Effective Time;
- (e) all information entitled to legal privilege, including attorney work product and attorney-client communications (excluding title opinions and title memoranda), and all information relating to the Excluded Assets and the Contemplated Transactions;
- (f) studies related to reserve assessments and economic estimates and analyses, including but not limited to internal valuation data, business plans, reserve reports and business studies;
- (g) all proceeds from the settlement or disposition of any Claims, proceedings, or disputes against Persons that are not an Indemnified Buyer Party to the extent such proceeds relate to the other Excluded Assets described in this Section 1.2;
- (h) to the extent relating to the other Excluded Assets described in this Section 1.2 or relating to matters for which Assignor has agreed to indemnify the Indemnified Buyer Parties hereunder or relating to any of the Retained Liabilities, all warranties and rights to indemnification;
- (i) all rights, Claims, refunds, causes of action, or choses in action (i) under the Transaction Documents or (ii) arising out of or relating to any of the other Excluded Assets described in this Section 1.2, the Retained Liabilities or any other matters for which Assignor is obligated hereunder to indemnify any Person;
- (j) data, software and Records to the extent disclosure or transfer is prohibited or subjected to payment of a fee, penalty or other consideration by any license agreement or other agreement with a Person other than Affiliates of Assignor, or by applicable Law, and for which no consent to transfer has been received after the exercise of commercially reasonable efforts by Assignor to obtain a consent, or for which Assignee has not agreed in writing to pay such fee, penalty or other consideration, as applicable;
- (k) the benefits derived from any Identified Tax Credits applicable to any period before January 1, 2020;
- (l) any claim, right or interest of Assignor in or to any refunds or loss carry forwards, together with any interest due thereon or penalty rebate arising therefrom, with respect to any and all Seller Taxes; and
- (m) Assignor's real property, office and improvements located at 235 Callahan Avenue, Parachute, Colorado 81635, also known as Lot 5 of Spring Lake Estates, Resubdivision of Lot 2A, Section E, Town of Parachute, according to plat thereof recorded April 4, 2007 as Reception No. 720483, being located in Section 7, Township 7 South, Range 95 West, Garfield County, Colorado and known as Assessor Parcel Number 240707205005.

## ARTICLE 2 SPECIAL WARRANTY AND DISCLAIMERS

Section 2.1 **Special Warranty of Title.** Except for the Permitted Encumbrances, Assignor hereby warrants unto Assignee, its successors and assigns that the Acquired Assets are free and clear of all Liens arising by, through or under Assignor or its affiliates but not otherwise. The Parties acknowledge and agree that the foregoing warranty shall constitute and be considered a special warranty of title by, through and under Assignor under applicable Laws.

Section 2.2 **Disclaimers of Representations and Warranties.**

(a) **IT IS THE EXPLICIT INTENT OF EACH PARTY, AND THE PARTIES HEREBY AGREE, THAT NEITHER ASSIGNOR NOR ANY OF ITS AFFILIATES OR REPRESENTATIVES HAS MADE OR IS MAKING ANY REPRESENTATION OR WARRANTY WHATSOEVER, EXPRESS OR IMPLIED, WRITTEN OR ORAL, INCLUDING ANY IMPLIED REPRESENTATION OR WARRANTY AS TO THE CONDITION, MERCHANTABILITY, USAGE, SUITABILITY OR FITNESS FOR ANY PARTICULAR PURPOSE WITH RESPECT TO THE ACQUIRED ASSETS OR ANY PART THEREOF, EXCEPT THOSE REPRESENTATIONS AND WARRANTIES EXPRESSLY CONTAINED IN THIS ASSIGNMENT OR THE PURCHASE AGREEMENT, AND WITHOUT IN ANY WAY LIMITING THE FOREGOING, ASSIGNOR MAKES NO REPRESENTATION OR WARRANTY TO ASSIGNEE WITH RESPECT TO ANY FINANCIAL PROJECTIONS OR FORECASTS RELATING TO THE ACQUIRED ASSETS.**

(b) **EXCEPT AS OTHERWISE EXPRESSLY PROVIDED IN THIS ASSIGNMENT OR THE PURCHASE AGREEMENT, THE ACQUIRED ASSETS ARE BEING TRANSFERRED "AS IS, WHERE IS, WITH ALL FAULTS," AND ASSIGNOR EXPRESSLY DISCLAIMS ANY REPRESENTATIONS OR WARRANTIES OF ANY KIND OR NATURE, EXPRESS, IMPLIED OR OTHERWISE, AS TO THE CONDITION, VALUE OR QUALITY OF THE ACQUIRED ASSETS OR THE PROSPECTS (FINANCIAL OR OTHERWISE), RISKS AND OTHER INCIDENTS OF THE ACQUIRED ASSETS.**

(c) Without limiting the generality of the foregoing, the representations and warranties contained in Section 4.20 of the Purchase Agreement shall be the exclusive representations and warranties with regard to Environmental Laws.

## ARTICLE 3 MISCELLANEOUS

Section 3.1 **Assignment Subject to the Purchase Agreement.** This Assignment is executed and delivered pursuant to the terms of the Purchase Agreement and is specifically made subject to the terms, conditions and covenants contained therein. In the event of an express conflict between the provisions of the Purchase Agreement and this Assignment, the provisions of the Purchase Agreement shall control. The Purchase Agreement contains certain representations, warranties, obligations and covenants between Assignor and Assignee which

survive the delivery of this Assignment and which shall not be merged into this Assignment, or otherwise negated by the execution and delivery of this Assignment. Notwithstanding the foregoing, third parties may conclusively rely on this Assignment to vest title to the Assets in Assignee.

**Section 3.2 Assumed Liabilities; Retained Liabilities.** Subject in each case to the terms of the Purchase Agreement, Assignee hereby assumes and agrees to pay, perform, fulfill and discharge the Assumed Liabilities. Subject in each case to the terms of the Purchase Agreement, Assignor hereby retains, assumes and agrees to pay, perform, fulfill and discharge the Retained Liabilities.

**Section 3.3 Further Assurances.** Assignor and Assignee agree that, from time to time, each of them will execute and deliver such other documents, certificates, agreements and other writings and take such other actions as may be necessary or desirable in order to consummate or implement expeditiously the Contemplated Transactions in accordance with the terms of the Purchase Agreement.

**Section 3.4 Governing Law and Venue.** This Assignment shall be governed and construed in accordance with the laws of the State of Colorado. The Parties agree that any actions or other proceedings arising out of or relating to this Assignment shall be brought by the Parties and held and determined only in the state or federal courts located in Denver, Colorado, which shall be the exclusive venue of any such action or proceeding. Each Party waives any objection which such Party may now or hereafter have to the laying of venue of any such action or proceeding, and irrevocably consents and submits to the jurisdiction of such court (and the appropriate appellate courts) in any such action or proceeding. If a Party brings an action to enforce its rights under this Assignment, the prevailing Party shall recover its expenses (including reasonable attorneys' fees) incurred in connection with such enforcement from the other Party, including any appeals. **THE PARTIES AGREE THAT THEY HEREBY IRREVOCABLY WAIVE THE RIGHT TO TRIAL BY JURY IN ANY ACTION TO ENFORCE OR INTERPRET THE PROVISIONS OF THIS ASSIGNMENT.**

**Section 3.5 Successors and Assigns.** This Assignment shall be binding upon and inure to the benefit of the Parties and their respective successors and assigns. All references herein to either Assignor or Assignee shall include their respective successors and assigns. All Exhibits attached hereto are hereby made part hereof and incorporated herein by this reference.

**Section 3.6 Subrogation.** To the extent permitted by Law, Assignee shall be subrogated to Assignor's rights in and to representations, warranties, and covenants given by others with respect to the Acquired Assets, and Assignor hereby grants and transfers to Assignee, its respective successors and assigns, to the extent so transferable and permitted by Law, the benefit of and the right to enforce the covenants, representations, and warranties, if any, which Assignor is entitled to enforce with respect to the Acquired Assets.

**Section 3.7 Counterparts.** This Assignment may be executed in counterparts, each of which shall be deemed an original instrument, but all such counterparts together shall constitute but one instrument. No Party shall be bound until such time as all of the Parties have executed counterparts of this Assignment.

**Section 3.8 Conspicuousness. ASSIGNOR AND ASSIGNEE AGREE THAT, TO THE EXTENT REQUIRED BY APPLICABLE LAW TO BE EFFECTIVE, THE PROVISIONS IN THIS ASSIGNMENT IN BOLD-TYPE ALL CAPS FONT ARE “CONSPICUOUS” FOR THE PURPOSES OF ANY APPLICABLE LAW.**

**Section 3.9 No Multiple Conveyances.** Assignor and Assignee acknowledge and agree that they may be required to execute separate deeds and assignments covering certain of the Assets conveyed hereby on forms approved by Governmental Authorities or other Persons to effect the conveyances of such Assets. Any such separate deed or assignment (x) shall evidence this Assignment and conveyance of the applicable Assets herein made and shall not constitute any additional conveyance of any of the Assets, (y) is not intended to modify, and shall not modify, any of the terms, covenants and conditions or limitations on warranties set forth in this Assignment or the Purchase Agreement and is not intended to create, and shall not create, any additional representations, warranties or covenants of or by Assignor or Assignee, and (z) shall be deemed to contain all of the terms and provisions of this Assignment, as fully and to all intents and purposes as though the same were set forth at length in such separate deed or assignment.




