**General Comment:**

COGCC environmental inspection to determine progress on Spill ID 484039. This is an environmental inspection. Any corrective actions from previous inspections that have not been addressed are still applicable. There were no operator or contract environmental personnel on location at the time of this field inspection. Photos attached to document site conditions.

Incident information: A Representative with the Town of Frederick contacted COGCC stating:

"[During monitoring well installation] we found some contaminated soil roughly 15ft in depth. The location of the groundwater monitoring well is in 2N 30S 67W at 40.102367, -104.941582" The monitoring well was reportedly installed during the week of March 6th, 2023.

On March 16th, 2023, COGCC notified the Operator, KP Kauffman (KPK), of the suspected release and requested a Form 19 Spill/Release Report be submitted. KPK submitted Form 19is (Doc #403349253) on March 17, 2023.
