Operator Comment: KPK filed a form 27 initial (Doc. 403182745) on 9/30/2022 for the UPRR 43 PAN AM I #23 site. Operator indicated that "following the approval, a form 19 supplemental submitted to close out the Form 19 under the approved remediation number." COGCC staff "Denied" the form on 2/14/2023 for alleged disposal manifest issues and because "proposed monitoring wells do not adequately characterize the site". Despite the foregoing,

Staff never provided comment on KPK's groundwater sampling plan other than stating it was inadequate. KPK had indicated the following:

During Geoprobings activities 3 temporary monitoring wells were installed to conduct groundwater monitoring. Results from the first sampling event were attached. Following the completion of excavation MarCom proposes the installation of 2 additional Groundwater Monitoring wells. Monitoring wells will be located in the following locations 1 at the source, 1 downgradient, 1 upgradient, and 2 cross gradient. (See map). Upon approval of the GWM plan, COGCC will be provided with a 72-hour notice before well installation. In addition, KPK filed Form 27 (Doc 403330347) on 3/15/202344 to request backfill of the excavation only; technical details related to this investigation and remediation have been provided for review on Form 27 doc #403182745. This form was also Denied by Staff despite an earlier iteration being returned to draft with the following COA:

"This Form 27 is conditionally approved to allow for expedient backfill of this excavation to mitigate a significant and ongoing public safety risk. COGCC will review associated Form 27 Document #403182745 to ensure an appropriate site investigation and remediation plan has been proposed and apply COAs or Comments to that document."

COGCC Decision: **Not Approved**

COGCC Representative: Operator has not submitted an approvable Form 27 for this incident. Conditions of Approval are not in effect until a Form is approved, not when a form is returned to draft.
