Set CIBP @ 4850' & 2 sxs cement
Pulled 5-1/2" casing from 3355'
40 sxs cement @ base of surface 8-5/8 from 110' up.
10 sx @ surface.
Cut off wellhead and weld plate 4' below ground level.
Restore surface location.

All cement was 50/50 poz, yield is 1.26 cu. ft./sack, weight is 15.1 ppg.
