A field specialist discovered a release of 15 barrels of crude oil within containment at the No Worries Ecopod. The facility was immediately shut in and cleanup has commenced. The investigation into the cause of the release is ongoing, but it appears there was a failure in the tank riser that led to the release of fluid.
