INITIAL ACTION SUMMARY

Description of initial action or emergency response measures take to abate, investigate, and/or remediate impacts associated with E&P Waste.

In accordance with COGCC Rule 911, this form serves as notification for the decommissioning and abandonment of the Rotharmel 22-32 production facility. The ground and sub-surfaces will be visually inspected for hydrocarbon impacts during equipment decommissioning. Field observations and photo documentation will be recorded in a field inspection form for submittal to the COGCC.

PROPOSED SAMPLING PLAN

Proposed Soil Sampling

Will soil samples be collected as part of this investigation? (Number, type (grab/composite), analyses, and locations of samples):

Grab soil samples will be collected below and/or adjacent to applicable facility equipment, as defined in the Rule 911.a.(4) guidance document (9/20/21), for field screening purposes. Discrete soil samples will be collected for laboratory analysis either in any area of observed hydrocarbon impacts, or in the sample locations designated by the COGCC. GPS data will be collected for all soil sample locations. Soil samples will be submitted for laboratory analysis of BTEX, naphthalene, total petroleum hydrocarbons (TPH C6-C36), 1,2,4-trimethylbenzene (TMB), and 1,3,5-TMB by EPA Methods 8260B and 8015. Additionally, soil sample(s) will be collected in the area most likely to be impacted by produced water to confirm soil suitability for reclamation. The sample (s) will be submitted for laboratory analysis of electrical conductivity (EC), pH, sodium adsorption ratio (SAR), and boron by saturated paste and hot water soluble extraction methods. Refer to the Proposed Sample Location Map.

Proposed Groundwater Sampling

Will groundwater samples be collected as part of this investigation? (Number, analyses, and locations of samples):

If groundwater is encountered during decommissioning and/or abandonment activities, a grab sample will be collected as soon as practical. If contaminated soil is in contact with groundwater or if free product/hydrocarbon sheen are observed, the release will be reported in accordance with Rule 912.b. Groundwater samples will be submitted for laboratory analysis of BTEX, naphthalene, 1,2,4-trimethylbenzene, and 1,3,5-trimethylbenzene by EPA Method 8260.

If a produced water vessel is present, discrete soil samples will be collected from the base of the excavation and excavation sidewall in areas most likely to be impacted and exhibiting the highest field screened VOC concentration. The soil samples will be submitted for additional laboratory analysis of EC, pH, SAR, and boron by saturated paste and hot water soluble extraction methods.

On March 9, 2022, three background samples (BKG01) were collected from native material topographically up-gradient of the wellhead location and submitted for analysis of EC. Analytical results indicated that EC was in compliance with the applicable Table 915-1 standard in native material.

Additionally, on January 4, 2023, six background soil samples (BKG02) were collected from native material adjacent to the production facility location between depths of 2.5 feet and 7 feet bgs and submitted for analysis of EC. Analytical results indicated that EC was in compliance with COGCC Soil Suitability for Reclamation standards in native material.

No soil was removed from the location during tank battery decommissioning and closure activities.

On January 4, 2023, five soil borings (SB01-SB05) were advanced via hand auger to confirm and delineate the vertical and horizontal extents of the EC exceedance observed in soil sample PWV01-B @ 4'. Six soil samples (SB01) were collected at 2.5 feet, 3 feet, 4 feet, 5 feet, 6 feet and 7 feet bgs, from soil adjacent to the former location of soil sample PWV01-B. All six soil samples collected from SB01 were submitted for laboratory analysis of EC. Additionally, four soil samples were collected at 4 feet bgs from the surrounding soil borings (SB02-SB05) to delineate the horizontal extent of the observed EC exceedance. Analytical results indicated that EC was in compliance with the Table 915-1 standards in all soil samples collected from SB01-SB05. Due to the elevated EC result in PWV01-B, six background soil samples (BKG02) were collected from native material adjacent to the production facility location at depths of 2.5 feet, 3 feet, 4 feet, 5 feet, 6 feet and 7 feet bgs, and submitted for analysis of EC. Analytical results indicated that EC was in compliance with the Soil Suitability for Reclamations standard standard in native soils. Analytical results are summarized in Tables 1 through 3, and GPS coordinates and field screened VOC concentrations are summarized in Table 4. The soil boring locations are illustrated on Figure 2. The laboratory report is included as Attachment A and the soil boring logs are included as Attachment B.

OPERATOR COMMENT

Analytical results for the soil samples collected during the supplemental site investigation conducted on January 4, 2023, indicated that EC concentrations were in compliance with the COGCC Soil Suitability for Reclamation standards in all soil samples. Based on the results, the initial EC exceedance recorded during initial decommissioning activities was a discrete location and native soil below and adjacent to the former produced water vessel location was in compliance with the Soil Suitability for Reclamation standards. Based on the information described herein, PDC is submitting a tank battery closure request for the Rotharmel 22-32 tank battery.
