 Field Inspector Actions:
 On 3-31-2023, I Randy Silver area field inspector was assigned a complaint received by COGCC staff in reference to Venting and spills. This is an anonymous complaint. The complainant Stated there has been multiple spills on site, Operator is leaving gauge hatched open 24hrs a day and not using ECDS to burn off excess gas. I performed a complete site inspection of the oil and gas location and associated wells in the area. At time of inspection, I did observe all three facilities venting and gauge hatches open. I observed a couple spots with stained soil but did not see any evidence of a spill. At time of inspection, I spoke with pumper and Supervisor Mani Silva. I informed him at time of inspection I observed all three facilities Crude oil tanks venting what appeared to be gas out of the open gauge hatches. Multiple violation on all three facilities were observed and documented in inspection documents.
