**General Comment:****COGCC Inspection Report Summary**

On 3/24/23 at approximately 13:30 hours, I, Inspector Corey De Paolo, Conducted an on-site inspection at TEP ROCKY MOUNTAIN LLC PUCKETT/TOSCO-66S95W /34NESW. Location #334570 Garfield County Colorado While there, I observed normal production operations. During this inspection the following compliance issues were observed:

- 1) Calibration cards not conspicuously posted with a corrective action date of 4/6/23.
- 2) Loadline open ended with a corrective action date of 4/3/23.
- 3) Capacity reduced due to stormwater in tank containment with a corrective action date of 4/26/23.
- 4) -Location lacks stabilization.
- Insufficient tracking BMP at entrance to location. To minimize the transport of sediment.
- Berms insufficient
- Run on to location is not being controlled with a corrective action date of 4/11/23.

- Location is located in a high priority habitat area.
