INITIAL ACTION SUMMARY

Pursuant to COGCC Rule 911 a site investigation was conducted pertaining to the SPIKE STATE D12-03 wellhead cut and cap and flowline abandonment. Approximately 724' of flowline was abandoned-in-place. The Form 44 document number will be provided on a supplemental Form 27. The wellhead was cut and capped per COGCC rules. Additionally, soil samples were collected at any points of material change and/or hammer unions, directional changes, as well as at the bell holes on either side of a waterway, AS APPLICABLE to abandonment type. The Flowline Pre-Abandonment Notice Document number is included under Related Forms.

Soil samples were analyzed by a certified laboratory for TPH (total volatile [C6-C10] and extractable [C10-C36] hydrocarbons) organic compounds in soil per COGCC Table 915-1, and EC, SAR, pH, and boron. All samples collected were analyzed by a certified laboratory using approved COGCC laboratory analysis methods.
