While the calibrator was on-site, he noticed bubbling in front of the separators for the Savage 5-24 A-D wells every time the wells offloaded. Less than 1 gallon of fluid was observed standing on the surface. The Caerus OCC and Route Pumper were notified of the observations, and the wells were shut in.
