This well was constructed to 32-ft, is now abandoned, no static water level recorded. Residential Well (DWR Receipt 0254765D, Permit 28326-F) is approx 340-ft to the E. This well was constructed to 1398-ft, no static water level recorded. Residential Well (DWR Receipt # 9004029, Permit 53539-) is approx 655-ft NE. This well was constructed to 305-ft, static water level recorded at 70-ft.

Groundwater less than 20 ft is not expected at the disturbance location.

Grab confirmation soil samples will be collected from beneath the above ground oil tank and separator. Soil samples will be analyzed by a certified laboratory for TPH (total volatile [C6-C10] and extractable [C10-C36] hydrocarbons), organic compounds in soil per COGCC Table 915-1, and EC, SAR, pH, and boron. All samples collected will be analyzed by a certified laboratory using approved COGCC laboratory analysis methods.
