On Wednesday, April 12, 2023 at approximately 11:30, I, Inspector Brittani Santistevan, conducted an on-site inspection at KING 42-29 (PDC Energy), at API #: 05-123-24620 in WELD COUNTY Colorado.

While there, I observed a shut in wellhead.

During this inspection the following possible compliance issues were observed:

1. It appears there is over grown weeds and debris inside wellhead fencing. Comply with Rule 606. (Corrective Action Date: April 26, 2023) See attached photo #'s: 3-5.

A follow up on this site inspection needs to be conducted to ensure the compliance issues have been corrected to comply with COGCC rules.
