**General Comment:**

On Wednesday 4/5/2023, I, Inspector Scott Ramsey and Kris Neidel, conducted a joint OGI camera inspection at Organic Energy Ellgen 11-10-1, at Location # 424294 in Moffatt county Colorado.

Any Corrective Actions from previous Inspections that have not been addressed are still applicable.

While there, I observed normal production operations. This location is within or in close proximity to a CPW Density/High Priority Habitat, black bear, NSO habitat, Wildlife Management.

Wind was light and temperature was around 30 degrees. We observed a line heater next to the vertical heated separator. Both heaters were running. ECD was running with slight heat trace observed with OGI camera.

During this inspection the following possible compliance issues were observed:

1. Some areas of location show signs of lack of stabilization and and no evidence of tracking BMP's.
2. Random staining from previous inspection around well head still present therefore C/A date remains the same 11/14/2022.
3. Stored equipment (tubing) from previous inspection is still present therefore C/A date remains the same 11/14/2022.

A follow up on this site inspection will be conducted to ensure the compliance issues have been corrected to comply with COGCC rules.
