General Comment:

on 3/14/2023 COGCC staff, Kris Neidel inspected the Emerald #1 location. Weather; 28 degrees, clear, mud was partially froze at time of inspection. COGCC staff was the only soul present at the time of inspection. There was a bellhole excavation at the wellhead. The well had been PA'd, cut, plate welded to well. The following was observed: pile of soil near an excavation where flowlines were day lighted, Pumpjack concrete pad near well, Pile of wood that appears to have been removed at well. Corrective actions: Concrete Pad should be removed, NOT incorporated into reclamation or buried. If soil stockpiled soil is impacted it should be removed as E&P waste. See attached photos.
