It was observed in this inspection that there is flowline equipment remaining at plugged and abandoned well API #045-17894 and #045-17865 (see attached photos). Form 6S #402983819 and #402983662 Operator comment "OOSLAT was applied to the wellhead line and abandoned in place."

Inspector cannot pass final reclamation on PA wells until associated flowline equipment is properly abandoned. Per Rule 1105.d.(1) Operator shall Submit Form a F42 notice of abandonment no less than 30 days before abandonment.
