Comment The western portion of the location does not appear to be necessary for production activities. This area needs to be reclaimed per the 1003 reclamation rules.

Interim areas to the north, east and south appear to have been reduced and reclaimed. Interim areas are vegetated with thinopyrum sp. No noxious weed concerns observed at the time of this inspection. However, dormant season and snow cover prevented a full vegetation assessment in interim areas. A follow up inspection will be performed in a future growing season to assess compliance with 1003 Rules.

Corrective Action Reduce areas no longer needed for production by 5/31/2023. If areas are reasonably needed for production activities, provide documentation in a factual review that outlines why areas outside a 100 foot radius of the well are necessary for production per rule 1003.b.
