COMMENTS:

Renegade requests approval of an alternative MIT for the Schroth-UPRR #22-21 as allowed for by Rule 417.b(3) after Director consideration of any equivalent test or combination of tests.

Renegade believes the Schroth-UPRR #22-21 demonstrates mechanical integrity due to a 4/8/2023 bradenhead test (Doc #403373197) performed showing no bradenhead pressure and tubing/casing pressure of 437/441 psi coupled with 2022, 2021, 2020 and 2019 annual bradenhead tests conducted showing no bradenhead pressure.

Schroth-UPRR #22-21 4-1/2" production casing was completed with a DV tool at 1401' and cemented with 200 sacks of cement and together with extensive remedial cementing have placed cement from 5265' to 80'. The 8-5/8" surface casing landing depth of the Schroth-UPRR #22-21 is 225'. The surface casing has been cemented back to surface with 200 sacks. The extensive remedial cementing performed at the Schroth-UPRR #22-21 is summarized in records filed at the COGCC and verified with a CBL. The Fox Hills water sand appears in the Schroth-UPRR #22-21 from approximately 1215'-1350'.

Renegade is attempting to get Western Gas Resources cooperation to sell or turnover abandon pipeline previously used to gather the produced gas from the Schroth-UPRR #22-21 allowing it to be aggregated with other adjacent wells to help with a commercial solution to gas production in the area. At this point we have been frustrated establishing a dialog. Utilizing the well's produced gas to supply an electrical generator for a data center operation could be the solution for gas disposition if pipeline cannot be secured. This well has been SI as a result of the Third Creek Gas Gathering System shutdown on 6/1/2018 and was producing at the time of SI. The Schroth-UPRR #22-21 was produced utilizing plunger lift equipment.

This Form 4 is being filed for the Schroth-UPRR 22-21 in response to a need for an alternative MIT approval to satisfy a COGCC rule to conduct MITs on wells SI longer than two years. Other Renegade wells with similar circumstances have had Form 4's previously approved.

A recent Form 5B Inactive Well Notice (Doc #403374757) has been recently filed for the Schroth-UPRR 22-21.

Due to the substantial cement protection confirmed by a CBL of the fresh water zones in the Schroth-UPRR 22-21 it is requested that the Schroth-UPRR 22-21 be given a three year approval for this alternative MIT submittal.

Conversations with the COGCC staff coupled with the well's circumstances has led to the belief that this filing is ripe for approval.
