General Comment:**COGCC Inspection Report Summary**

On Wednesday, 4/19/2023, Inspector Kirby Burchett, conducted a routine field inspection at KT Resources on the WRD Wyatt 36-23 well, Location #316142, in Rio Blanco County, Colorado.

This location is within or in close proximity to Parks and Wildlife (CPW) with High Priority/NSO/Density Habitat regulations.

Any Corrective Actions from previous Inspections are still applicable.

While there during normal production operations the following compliance issues were observed:

1. API Numbers not displayed on tank battery sign.
2. Gas meter calibration card not visibly displayed.
3. Insufficient BMPs to control vehicle tracking.
4. Open end tank valve.
5. Soil staining at tank battery.
6. Chemical tank not in use.
7. Illegible chemical tank labels.
8. Chemical containments full of liquid.

A follow up on this site inspection will be conducted to ensure all compliance issues have been corrected to comply with COGCC rules.
