<p><b>RECLAMATION COMMENT</b></p> <p>Inspection #696204522 observed that interim reclamation of areas not needed for production operations have not been performed.</p> <p>Inspection also observed Undesirable Plant Species on the Location. Inspection required Operator to comply with 1003 rules.</p> <p>It was observed in this inspection that interim reclamation activities appeared to be in process- areas not needed for production have been recontoured. Compaction alleviation appears to have been performed in one direction; unclear at time of inspection if areas were cross-ripped. Operator appears to have hydromulched/seeded most of the interim areas, as well as remaining soil stockpiles; unclear at time of inspection if mulching activities have been completed on northern interim areas.</p> <p>A followup inspection will be conducted to determine compliance with Rules 1002.f/1002.c, as well as Rules 606.c/1003.f</p> <p>Interim Reclamation "in process".</p>	trujilloam	04/18/2023
<p><b>STORMWATER COMMENT</b></p> <p>Location does not appear to have been constructed with an engineered outlet to mitigate ponding on site, and to allow for stormwater to discharge from the working pad areas in such a manner that minimizes erosion, degradation and off-site sediment transport- ponding on north end of the Location observed, unclear if this is stormwater, or related to hydromulching activities. Stormwater ponding can contribute to the destabilization of the working pad surface; inadequate runoff protections can result in erosion, degradation and sediment transport to the working pad, the interim, and/or other off-site areas.</p> <p>Review of SW BMPs on Location advised.</p> <p>Continue to monitor/manage stormwater on the Location; ensure BMPs remain adequate for the site's conditions, and in proper functioning condition in accordance with good engineering practices.</p>	trujilloam	04/18/2023
