Ran DST #2, 6200-7600', open hole, packer @ 6140', 9/16" BHC, 1/4" SC. Open 5 min, SI 30 min, open 60 min, SI 60 min. Rec'd 1120' fluid, apparently oil base mud, no gas. IH 2610#, 5 min IF 445#, 30 min ISI 567#, 60 min FF 485-500#, 60 min FSI 500-621#, FH 2596#.

Ran 50 jts, 1393.55', 5" slotted liner, and 4 jts 113.73' not slotted, total 1507.28'. Ran on drill pipe, bottomed @ 7595', hanger @ 6088', 112' lap. Set hanger, rel DP. Pulled & LD DP, nip'd down, instl'd well head, released rig, 12 MN 10/6/74.
