On Tuesday, 4/25/2023, Inspector Kirby Burchett, conducted a follow up field inspection at Scout Energy Partners on the McLaughlin A C 35 well, Location #314489, in Rio Blanco County, Colorado.

This location is within or in close proximity to a Parks and Wildlife (CPW) District with High Priority and Density Habitats.

Any Corrective Actions from previous Inspections are still applicable.

Follow up inspection is in response to FIRR #403376459 for Corrective Action from Inspection #702501074 on 4/5/23.

While there during normal production operations the following compliance issues were observed:

1. Blading of location and access road did not correct needed Stormwater BMPs to control potential sediment discharges from operational roads, well pads, and other unpaved surfaces.

A follow up on this site inspection will be conducted to ensure all compliance issues have been corrected to comply with COGCC rules.
