3. Spot 20 sack cement plug at 2610'.
4. Pull up and spot 35 sack plug 50' in & 50' out of bottom of surface casing at 586'.
5. Pull up and run 10 sack plug at surface.
6. Cut off surface below plow depth and weld plate on.
7. Clean location & move off.
