

SUNDRY NOTICES AND REPORTS ON WELLS

INSTRUCTIONS

Notice must be given to the Director, and approval obtained in advance of the time when the owner or operator expects to recomplate or abandon a well or to change plans. Within thirty (30) days after recompletion, change of plans, or remedial work, a detailed report of the work done and the results obtained shall be submitted on this form in duplicate for wells on Patented and Federal lands, and in triplicate for wells on State lands. In work that affects only rods, pumps or tubing or other routine work such as, but not limited to, cleaning out to previous total depth, no report is necessary.

(DETAILS OF WORK)

Plan of Work:

1. Rig up pulling unit, lay down rods and tubing, move out pulling unit.
2. Move in casing pulling machine, set wood plug at 4000', dump 1 sack Calseal and 9 sacks cement on plug. WOC overnight.
3. Load hole with water, rig up casing jacks.
4. Work 7" casing and run back off shot to calculated free point.
5. Pull and lay down 7" casing.
6. Set plug at 586' and dump 10 sacks cement on top of plug.
7. Cut off casing head, set 5 sack plug at surface and erect dry hole marker.
8. Clean up location.
