On Wednesday, April 26, 2023 at approximately 11:15, I, Inspector Brittani Santistevan, conducted an on-site inspection at RAINDANCE FC 23-369 HN (PDC Energy), at API #: 05-123-35099 in WELD COUNTY Colorado.

While there, I observed a producing wellhead.

During this inspection the following possible compliance issues were observed:

1. Old operator signage displayed on wellhead. Remove to comply with Rule 606.

(Corrective Action Date: May 26, 2023) See attached photo #2.

2. It appears to be stained soil under master valve. Conduct maintenance on equipment, cleanup stained material and review self inspection processes per Rule 1002.(2).d.

(Corrective Action Date: May 26, 2023) See attached photo #3.

3. Disconnected/unused valve at wellhead. Reconnect or remove equipment to comply with Rule 606. (Corrective Action Date: May 26, 2023) See attached photo #3.

A follow up on this site inspection needs to be conducted to ensure the compliance issues have been corrected to comply with COGCC rules.
