It was observed in this inspection that reclamation appears to be progressing towards a uniform, desirable perennial vegetative standard. Perennial grasses observed establishing beneath remaining mulch, and throughout the reclaim.

A few individual Halogeton plants were also observed; weed management is required until site receives a passing final reclamation inspection- weed management advised to prevent the further spread and establishment of undesirable plant species.
