**Weather Conditions: sunny, wet ground

On Thursday, April 27, 2023 at approximately 09:30, I, Inspector Brittani Santistevan, conducted an on-site inspection at RAINDANCE FD 20-322 HN (PDC Energy), at API #: 05-123-44984 in WELD COUNTY Colorado.

While there, I observed a producing well.

During this inspection the following possible compliance issues were observed:

1. It appears to be stained soil at wellhead. Conduct maintenance on equipment, cleanup stained material and review self inspection processes per Rule 1002.(2).d. (Corrective Action Date: May 27, 2023) See attached photo #3.

2. Unused/disconnected equipment at wellhead. Reconnect or remove from location per Rule 606. (Corrective Action Date: May 27, 2023) See attached photo #3.

3. Previous operator signage displayed on wellhead. Remove to comply with Rule 606. (Corrective Action Date: May 27, 2023) See attached photo #4.

A follow up on this site inspection needs to be conducted to ensure the compliance issues have been corrected to comply with COGCC rules.
