INITIAL ACTION SUMMARY

Description of initial action or emergency response measures take to abate, investigate, and/or remediate impacts associated with E&P Waste.

This form has been prepared to provide prior notice of the permanent removal of the flowline associated with the Pace Connelly Gas Unit #1-26 O SA Facility as depicted on Figure 1. This is in addition to the closure of one aboveground storage tank (AST), one produced water vessel (PWV), one meter house, and one separator as proposed in the Form 27 Initial dated December 12, 2022 (Document No. 403256848). The flowline system pre-abandonment notice was submitted under Form 44 Document No. 403384736. In accordance with COGCC Rule 911.a., soil samples and a groundwater (if present) sample will be collected following removal of the equipment to determine if soil and groundwater (if present) meet the concentration levels of COGCC Table 915-1. Visual inspection and field screening of soils around the equipment and associated flowline will be conducted during sampling activities. The Form 44 is attached.

Soil will be field screened along the flowline. Samples will be collected if indications of impacts to soil or groundwater are present. If impacted soils are encountered, a waste characterization soil sample will be collected from the area exhibiting the highest degree of impact based on visual, olfactory, and/or field screening observations. In the absence of apparent impacts, a soil sample will be collected from the areas most likely to have been impacted during the operational life of the flowline. Soil samples will be submitted to an accredited laboratory for analysis using standard methods appropriate for detecting the target analytes in COGCC Table 915-1. Proposed soil sample and screening locations are provided on Figure 1.

If groundwater is encountered during facility decommissioning activities, a minimum of one grab sample will be collected as soon as practical. Groundwater samples will be submitted to an accredited laboratory for analysis of benzene, toluene, ethylbenzene, total xylenes (BTEX), naphthalene, 1,2,4-trimethylbenzene (TMB), and 1,3,5-TMB, using standard methods appropriate for detecting the target analytes in COGCC Table 915-1.

If no impacts are observed following removal of the flowline, soil samples will be collected from the areas most likely to have been impacted during the operational life of the flowline for laboratory analysis of BTEX, TMBs, naphthalene, and total petroleum hydrocarbons (TPH) - gasoline range organics (GRO: C6-C10) by United States Environmental Protection Agency (USEPA) Method 8260D, TPH - diesel range organics (DRO: C10-C28) and oil range organics (ORO: C28-C40) by USEPA Method 8015D, pH, specific conductance (EC) and sodium adsorption ratio (SAR) by saturated paste method, and boron by hot water soluble soil extract method. If impacts are encountered, the soil samples will be submitted for laboratory analysis of the full COGCC Table 915-1 analytical suite.
